Yoorrook Justice Commission

When a person whether they are a male or female going for a Kidney Stone extraction, they will have a stent inside of them so the Kidney Stones can fall down the stent and one will urinate them out of one's body.

Weeks later one will have to go back into hospital to have the stent removed.

So, this is the NORMAL!!!

Yet it seems like a simple operation procedure it just is.

Home-May 5th Friday 2023

It was on this day that I was feeling sick, yet it seemed to me it wasn't that great of a problem but on that day, I was getting hot and cold, and I resorted to taking panadol to relieve the symptoms.

I thought I had just a bad sickness from a bug or something.

It could not have been Covid as I had for each year once over five years the Covid booster and each year at would make sure that I have my Flu Shot for that period been once every year over a five-year period the flu booster.

At this time there was no pain down below and I was urinating ok.

I told my partner about it, and she said go to bed.

was also sick during that time and we both knew we had to rest.

Home-May 6th Saturday 2023

It was on the Saturday May 6th, 2023, it was getting worse the hot and cold flushes to where I was shivering and had to put more blankets on the bed to keep myself warm, and then I was getting so hot with perspiration coming out of me.

I was still urinating ok and drinking heaps of water and taking Panadol.

There were no pain symptoms from down below.

was still sick, and I thought well she must have the same as me been sick.

Hospital-May 7th Sunday 2023 at

: Admitted

No recall of a Covid Test.

On Sunday everything was getting worse for wear, the fever started to increase so much in just so short of time from Friday.

Still the hot and cold flush intensified.

I was still urinating ok and drinking heaps of water and taking Panadol.

There were no pain symptoms from down below.

I had no clue what was going on, and that night because was sick a friend drove us to

That night at Emergency in the Hospital, I became a patient, and put onto a bed to where I wanted to urinate.

I pressed the buzzer, and the nurse came in and I said to her I needed to urinate.

The nurse was gone for 5-10 minutes.

I urinated (wet) my pants.

I urinated (wet) my pants due to the nurse not finding a wee bottle for me to wee in.

My pants are now on the floor and left there.

And the nurse changed the bed and I had to put a gown on.

Hospital-May 8th Monday 2023: Operation

Not sure here whether I spent the night downstairs or up in Ward 6.

The next day I can clearly say I was told I had a Kidney Stone infection and had to undergo an operation, I also had a KIDNEY INFECTION: BLOOD INFECTION and PNEUMONIA, don't remember this part.

In writing this now and recalling what happened, told around the end of August 2023 by my doctor from the second s

So, looking back to what I had I was a sick boy and close to death.

I did not feel anything down below and there was not any pain whatsoever to ever indicate that I had kidney stones to my own senses.

I was trolleyed down to theatre.

I was getting prepped for the operation I had to have a bung in my arm for a drip.

I know the nurse who stuck the drip into my arm I would have to say this nurse should not be anywhere near a needle as she hurt me.

I visible seen the Surgeon not knowing who his name was.

I remember a Chinese Doctor saying to me we may need to use a bigger needle.

The operation was my first medical procedure been under anaesthetic.

In that moment I just did not care because I was just so sick.

I was back in Ward 6.

I woke up and what I felt was this excruciating pain down below and did not have a clue what it was until I found out it was a catheter.

It was unbearable as the pain just went through my body the pain was intense.

I have not got a clue how they stick a catheter on one person but to me the day I came out of the operation I tell ya I was nearly standing from the pain as it was so intense that it was nearly squeezing my penis off.

My throat was dry and very sore.

I had to drink water to bring moisture to my throat.

When it was time to eat, I could not taste the food.

My taste buds disappeared from my sensory.

In hospital the food I could not taste a thing.

I have not got a clue how my throat had anything to do with having an operation on Kidney Stones

It felt like someone jammed something down my throat.

During the time I was in there I could hardly sleep I thought this was just due to my sickness or just coming out of the operation symptoms.

I was still in pain down below from the catheter, my throat sore and the feeling of something within my body the stent.

One night in there an elderly woman a nurse, came to look after me, and she said to me this drip that was on my left arm around the joint near my elbow front ways, she said it had to be taken out and she put this drip behind my left hand, and there wasn't much I could do about this because I wasn't in no condition to argue with her as she was the nurse.

The next day unbeknown to me the place the drip was behind my left hand was just dangling there with no support and I accidently bumped it due to try moving the blankets back on me and I remember I yelled out to the day nurse who was looking after me that day as my left hand started to blow up like a balloon.

The young nurse quite shaken up about this and with her quick thinking she removes the drip and bandaged my left hand up with a bandage.

To my surprise by the young nurse doing this to my left hand it began to go down slowly.

I was absolutely off my face on whatever was in those drips and trying to come to terms with the operation and sickness.

For me to urinate was hard as this was completely in unfamiliar territory to me.

I had a bag to urinate into.

I cannot remember if I had blood in my urine.

If there was it was a good thing both the stent and the catheter were both joined together.

And still both the stent and catheter were very painful.

What I did find out is that when I first went to soil (faeces) in the toilet, my faeces were like, squashed up and very mushy and watery it was hard to excrete the faeces.

Thinking back now I had to go back into the toilet because I thought I never wiped my backside.

So, my faeces were not properly coming out of my backside which was very odd.

My back passage felt like someone shoved something up there as it was very awkward to sit, and it felt like my anus was open somehow.

Was this part of the operation.

The day of coming home the removal of the catheter.

When the male doctor took it off by crikey the pain went through me, and my penis felt like it was gasping for air itself to breathe.

Well halleluiah!

Thinking the pain will be gone.

My legs were gone.

The pain remains.

At home from May 10th, Wednesday: 2023, to May 22nd, Monday: 2023, this is what I encountered:

For this procedure there was problems as I had to come back to have another procedure to have Laser treatment within my penis, so the Kidney Stones could fall into the stent.

So automatically this was not a NORMAL OPERATION !!!

Dawn says they sent me home with medication to take but to this day I cannot remember the medication that I had taken so to me that freaks me out only the stuff that is in my mind that I do remember.

I am still in so much pain.

Advised to drink heaps of water, which I could hardly do as water is something that is so hard to take when one is sick and in pain.

No lifting!

No information about the operation/procedure about the Kidney Stones and why to the reason of the mechanics that they had done to me within me with the stent.

I did not know at the time as months later I found out one would/could have a DISCHARGE PLAN.

With this procedure/operation to where I had to come back for Laser Treatment, I should have had a DISCHARGE PLAN, as I never received one.

I was going through the motions of the effects to the catheter.

I kept thinking to myself the pain should have gone by now, but it remained there for whatever reason I do not know.

The clothes I was wearing was very loose, my penis every time I touched the cloth the tingling or burning sensation from my penis was incredible.

Was I interfering with the way they stuck the stent in with my clothing.

No something is wrong here.

Every time this happened, I was always in discomfort of pain.

I could sleep one and a half hours to two hours of sleep in one time, once I would move or try to position myself to be comfortable it would keep me awake for another one and a half hours to two hours, so it was repeating itself to me.

My throat is still dry and very sore so here I am drinking heaps of water to ease the dryness to bring moisture to my throat.

When it was time to eat, I could not taste the food.

My taste buds were completely gone.

I still have that feeling like someone jammed something down my throat.

I have tried every trick in the book from brushing my teeth and my tongue a couple of times, gargling my mouth with Listerine and with salty water a couple of times to kick-start something but everything is failing me.

I tried eating mint could not taste it nor could I taste lemons for that matter.

My arms are still sore from the drips.

I am trying to place my arms and hand in a way that I can feel comfortable, but one can still feel the pain of the needle when I accidently bumped it myself been in an altered state of mind of not remembering about it due to lack of sleep and the awaking of nurses.

To stand, walk and sit to try and urinate I found quite embarrassing, it was hard to stand and urinate, and one could feel the operation from inside one's penis.

One could feel the effects of the catheter pain from around one's penis.

I had to sit on the seat of the toilet as I could not urinate straight; the urine would be more like a shower head or sprinkler going everywhere.

I had to urinate slowly.

Still going to soil myself on the toilet (faeces), my faeces are mushy, watery, and squashed.

What I did find out is that when I first went to soil (faeces) in the toilet, my faeces were like squashed up and very mushy and when it was watery it was watery.

Here I am I could feel this connection between both the stent through my penis and my back passage my anus, the feeling was eerie and disgusting.

And I felt on my backside my anus itching around the base of my anus became so irritable, and to changing of my underwear.

Still that feeling like someone stuck something up my backside anus.

My heartbeat became different, I told about it due to sleep.

Between my penis and my backside through discomfort, lack of sleep, and not been able to sit properly, which also would have made my blood pressure high, and lows and I had no idea where I stood with my Diabetes.

Urology Hospital-May 22nd Monday 2023

On the 22nd Monday 2023, I had to go back into hospital for a day surgery to have the kidney stone for laser treatment.

I briefly met the surgeon her name was

So, this was going to be my second operation on the kidney stones.

I thought, yes thank you so that this pain could go away.

I came out of it feeling good to where I was sitting in the hospital and came back home.

No one told to me about what I would be experiencing from the operation only that night I went to the toilet to find out that when I had passed urine, I cannot to this very day describe the pain I went through.

At first it felt like razor blades, but it was more that it was, different the pain indescribable.

The second time I had to go to the toilet I urinated slowly, and the pain was gone.

From May 22nd Monday: 2023, to June 6th Tuesday: 2023

Still no information about how to deal with urinating blood from one's penis but urinating slowly.

I am still in so much pain.

Drink heaps of water, which I could hardly do as water is something that is so hard to take when one is sick and in pain.

No lifting.

No information but it seems LIP SERVICE is easy to give as INFORMATION !!!

All the medical team that is involved here seems to think that this is just another straightforward kidney stone procedure, and I do not know even if realised that I had a KIDNEY INFECTION: BLOOD INFECTION and PNEUMONIA.

Still no DISCHARGE PLAN!!!

Or any indication of a FOLLOW UP!!!

At home, my friend who took me to the hospital on the May 7th Sunday came to see me and got Ural in which we could not get to a chemist after the operation.

I could feel the effects of the operation like something was about to move.

I am still in so much pain.

I went to the toilet, and I urinated, and blood came out and the pain was so intense it was worse than fire; it really burnt inside of me I could hardly move again.

The second time again I remembered to urinate slowly.

Drink heaps of water, which I could hardly do as water is something that is so hard to take when one is sick and in pain.

No lifting.

The Ural is helping me urinate.

I could still feel the burning sensation of urinating been so painful.

I am stilling feeling the effects of the catheter.

After the laser treatment the effects of the stent has woken up the pain from having a catheter from the first operation.

Where the catheter was situated, the pain has got worse.

Again, the clothes I was wearing was very loose, my penis every time it touched the cloth the tingling or burning sensation from my penis was incredible.

Was I interfering with the way they stuck the stent in with my clothing.

No, I said this has got worse from the first operation and now the second operation has increased more pain and sufferance.

Something is wrong here.

Every time this happened, I was always in discomfort of pain.

My sleep habit began to lower itself down to one hour to one and a half hours.

Once I would move or try to position myself to be comfortable it would keep me awake for another one hour to one and a half hours.

So, it was repeating itself to me.

This is getting bad to my sleep pattern.

I am in another zone deprived of sleep deprivation.

No information about the awakening of the catheter, from the first operation to where the pain will increase itself due to the second operation.

No information of the effects of one's penis to touch anything plus the sleep patterns.

Still no DISCHARGE PLAN or any indication of a FOLLOW UP.

The second operation and my throat are still dry it has got worse.

And very sore so here I am drinking heaps of water to ease the dryness to bring moisture to my throat.

When it was time to eat, I could not taste the food.

My taste buds were completely gone.

I still have that feeling like someone jammed something down my throat.

I have tried every trick in the book brushing my teeth and my tongue a couple of times, gargling my mouth with salty water a couple of times, and even trying to use Listerine to kick-start something for me but everything is failing me.

Tried eating mint could not taste it nor could I taste lemons for that matter.

Since the first and now the second operation my arms are still sore from the drips

I am trying to place my arms and hand in a way that I can feel comfortable, but one can still feel the pain of the needle when I accidently bumped it myself been in an altered state of mind of not remembering about it due to lack of sleep and the awaking of nurses.

To stand and try to urinate I found quite embarrassing, it was hard to stand and urinate, and one could feel the operation from inside one's penis.

One could feel the effects of the awakening of the catheter pain from around one's penis.

I had to sit on the seat of the toilet as I could not urinate straight, the urine would be more like a shower head and sprinkler spray going everywhere.

I had to urinate always slowly.

It has not changed from the symptoms of the first operation and now the symptoms of the second operation are getting worse.

From the second operation my soiling of faeces has got worse.

More fluid is passing through my anus back passage it is like I am urinating down my back passage.

It has got worse, and I mean worse its right in my head and right now I am so confused about why this is happening.

When going to soil myself on the toilet (faeces), my faeces, squashed up and very mushy and waterier.

Here I am I could feel this connection between both the stent through my penis and my back passage my anus, the feeling was eerie and disgusting.

And the feeling on my backside my anus itching around the base of my anus became so irritable and it is increasing itself as really annoying I am trying to tolerate it, but it is now in my head.

Faeces is coming out of my anus backside with no control, and it is embarrassing.

The changing of my underwear is constant not one day every day.

Still that feeling like someone stuck something up my backside anus.

Since the second operation my heartbeat has increased.

My heartbeat is different, I told about it due to sleep and the constant pain and irritation.

Between my penis and my backside through discomfort, lack of sleep, and not been able to sit properly, which also would have made my blood pressure high and lows.

I can easily feel myself drifting away into another space it is like sometimes I am hallucinating but this is real, and it is keeping me awake for my own reality.

Urology Cancelled-June 6th Tuesday 2023 at Level 1, 11.30am: Reception Desk at Day of Surgery Admissions-Cancelled

By mail I have received a letter to say that the stent removal date has cancelled.

What!!!

Here I am still going through the motions with this thing called an INTRUDER the STENT and I must wait two more days for it to removed.

What!!!

Urology Covid-June 8th Thursday 2023 at Level 1, 11.30am: Reception Desk at Day of Surgery Admissions-Cancelled

So, on this day I rock up, and to find myself having a COVID TEST:

What!!!

Leading up to having the stent removed the fact that I never went anywhere at all.

I was home in bed and in no frame of mind or body to be walking around anywhere.

was house bound due to not leaving the house and our food delivered to the door.

I recall the day before the operation to have the stent removed done shopping because she could not get anyone to do it.

It was on July 6th Thursday 2023 at level 1: 11.30 am that I was going to have the left stent removal with a

I arrived there at that time quite early because I just wanted to have this removed from inside of me.

I did not know anything at the time about the procedure before an operation; I had to have a Covid test.

I was in that room until I got up and walked outside the cubical and said what is the problem.

So, the two young nurses said I will have to get our supervisor because there were irregularities about my Covid test.

I had Covid.

I was quite shocked myself as I had the five Covid needles and had five Flu shots and locked up mostly in a room at home not going anywhere.

And only went out once due to me going into hospital for the operation of the stent removal.

Anyway, the head nurse or sister who was in control of the ward that day said to me that I had to come back again possible in four weeks' time.

I said I had the Covid shots and Flu shots, and I did not even feel like I had Covid as to me I felt to me is this a joke.

I asked the boss nurse of the day on that ward who gave this order, and she told me it came from and that he was the boss of this department and that it was hospital policy or something like that for anyone to have Covid they had to wait four weeks.

I said to the boss nurse I could have picked this up just walking through the door.

She looked at me with silence.

To me that day and the way she spoke to me it was like she was going to evict me from the ward with security and I could see this was where she was heading.

I could not argue with the boss woman of the day, so I left.

To me leaving that day I had to come back home and go through another four weeks of hell, as to me it felt like four weeks of mental, physical, and spiritual pressure.

To me my life was now on the line due to sleep deprivation and not been able to contain two litres of water each day.

From this day I felt like I was dying inside I could feel my heart nearly giving out and my eyes was going red

In leaving here no DISCHARGE PLAN or any indication of a FOLLOW UP.

A simple five-minute procedure to have a stent removed and told to come back in 28 days' time, what a sick joke or better off this is your own punishment.

So, from June 8th Thursday: 2023, to July 6th Thursday: 2023, I felt like I was now dying.

A hospital is there to save lives.

A Doctor should have been on hand to see me straight away to find out what was going on about my condition, but it never happened.

The boss nurse had no intentions to do nothing about listening to me or to ever try to see reason to what I was trying to tell her.

Another word it was her word or the highway for me.

She gave us no information how to combat myself for another four weeks of the intrusion of one of their intruders the stent, which was inside of me giving incredible grief to my life of health and wellbeing.

I was still going through the motions of the pain still imbedded within me of the catheter.

The stent as usual is still creating havoc, still unable to urinate properly and I had to sit down when urinating.

There still is no taste for either drink or food.

Could hardly soil (faeces) it has got more mushy, runnier and is still running out of me like I am urinating down my anus my backside.

My heartbeat has increased, and my sleep is so short in small intervals I do not think I can last another four weeks of this.

My sleep pattern is out of order it is not funny.

I am praying here to God.

Urology Hospital -July 6th, 2023,

I have now somehow reached the milestone of the above date mentioned.

My penis is going bluey black and on the outside of the colour its going whitish I can easily see it when in front of the mirror and that pain that niggling sensation from when the catheter was put over the top of my penis the pain is still there, and it is not going away.

So here I am at the hospital waiting early again, and I am expecting to have another Covid test.

I do not see the boss nurse anywhere she may be there somewhere, but she is out of sight, so another nurse comes out and said to me that they are ready for me to get the stent out.

So, I said to her hey are you going to give me another Covid test, and she said no you are good to go and no Covid test.

To me alarm bell began to ring as I thought hey, they could have been talking together about the stent needs to come out regardless no Covid test given to me.

It was quite late that day when I went into for the stent removal, I remember it getting dark or maybe that was me imagining this, but it was late.

I remember coming home and wanting to go to the toilet, and when I urinated wow that burning razor blade sensation just went through me.

I nearly blacked out I looked down and seen the blood and not long after that I had to go again to urinate and this time, I had to think quickly how to beat that burning sensation, so I urinated very slowly, and the burning went away.

I found the secret of urinating after an operation procedure I do not know.

Still no DISCHARGE PLAN or any indication of a FOLLOW UP!!!

The first thing is that the stent is now out and hopefully I can recover to have good quantity and quality of sleep.

The catheter is still annoying it is still there actually after the stent came out it got worse over nights and then fell back into that throbbing annoying thing around my penis.

I am urinating blood again it is killing me please Paully urinate very slowly.

My heartbeat is still constantly beating weakly, and this is scaring me regardless of the removal of the stent.

My faeces are stilling running out of me like I am still urinating down through my anus backside.

The next day at home: July7th Friday:2023, blood is still in my urine, but I am now aware of the danger when urinating, so I am still urinating really slowly and now pain, but I am sitting on the toilet for ages to allow to make sure the urine is passing through me

At Home-**July 8th Saturday: 2023**, the pain is going and but the sensation feeling of the stent I can still feel where it has been.

I can still feel the strength of the catheter of where it was and it is still throbbing, I have no idea of how they put it over my penis.

Discharge Plan-July 16th Sunday.

Here I am finding out for the first time is that there is this thing called a DISCHARGE PLAN!!!

My friend went to

to have an operation to have her appendix removed.

In her discharge, something went wrong with her as she had an infection or something like that and she had to go back again, and have it checked out to where she had to have another operation to fix it back up again.

When she released from the they asked her if she wanted a Discharge Plan.

And she did not even know about a thing called a DISCHARGE PLAN at all, it blew her mindset away about knowing this.

She contacted me to tell me about the DISCHARGE PLAN and so I researched about it, and this also blew my mind away.

I am still going through the motions from the Kidney Stone procedures/operations and the removal of the stent.

My heart is pounding differently: my faeces is still the same only getting worse, the catheter pain remains, and I am feeling so vulnerable it is not funny like I am collapsing through exhaustion and through sleep deprivation.

On September 5th Tuesday 2023 and September 6th Wednesday I rang the hospital for Complaints.

And so, I said that I wanted to make a complaint against what was happening to me about the Urology Procedure and the treatment within the **sector sector** within this department Urology.

I also told him about the negligence of why I have I been feeling like I have been Urinating down my back passage in my anus.

Yet still going through the motions and trying to recover, it is on **September 12th Tuesday Discharge** from within happened from me of not knowing.

This morning, I was sitting on the toilet wanting to urinate and I nearly collapsed because a pain went right through my body so I got off the toilet ran in and told that I had to go to the ital straight away because the burning sensation was just too much for me.

I went into the shower to have a shower and in there I really wanted to urinate it burnt me I was in such pain like no other and from nowhere I was like really pushing down as if something was stuck in the inside my penis and so I pushed and pushed and out came this long blog.

I did not know what it was I absolutely scared, as my penis was in pain like no other and this piece of whatever was just lying on the bottom of the shower floor.

I called and so she got a small plastic container and put it in the fridge so that I could take it to the doctor.

I can still feel the pain around and inside of the catheter it still with me.

The piece of blog was Skin Tissue telling me that the Surgeons ripped the stent into me, they damaged me inside.

So, from my complaint on dates September 5th Tuesday 2023 and September 6th Wednesday I finally got a letter to contact Urology at last so here I am.

assistant is fronting me and have asked me what the problem is about me.

So, I say to her you tell me you must know all the aftereffects of a stent.

And she just stares at me and asks what's the problem.

She gave me the understanding she did not have a clue about anything connected to knowing about my problems.

She never understood anything about what I as a Urology Patient would have and is still experiencing.

To me she is rude and should not be even working within this section of the department of the hospital.

She gave me the impression she wanted to get rid of me without her own understanding of why I was there.

So anyway, I have given her the information of why I am there.

She still has no understanding of the symptoms or pain that I have endured.

She gets the Surgeon

He comes in and tells me that when and during the operation is that he had to put a plastic tube or whatever to the end of the stent and this is the first time I am hearing this, of a so-called NORMAL OPERATION!!!

So, for the first time now I am understanding why I could not sleep, my heart pounding, and could not sit down properly plus not crapping properly and interference with my movement of my bowels been the way they were.

I present to him the SKIN TISSUE in a container, and he sees it and throws it into the bin another words he knows he has made a mistake, and he knows his surgery is totally went wrong!!!

When Skin Tissue comes out of one person it tells the roughness of the surgeon/s capabilities.

On October 5th Thursday:2023 my head was so heavy, and it never allowed me to go to sleep, so we rang the Ambulance up, to see me.

My blood pressure was 202 - right through the roof which could have created a heart attack from so much pressure upon my brain.

I told the Ambulance LADIES!!!,

I believe build up from the pressures of Urology through both my faeces and urine which smelt like ACID!!!

This put pressure upon my head to create it in a space where my blood pressure was incredibly high.

Again, admitted to the

In hospital they ran so many tests through my blood, and I had a CAT SCAN which came back normal.

That night they put a drip within my body and my body started to back down again especially my blood pressure.

So here I am again after a so-called normal operation/procedure of a Kidney Stone removal and things have not changed, mind you I am getting sick of repeating myself here it is ridiculous.

Both my Anus and Penis from within both are on fire through the stench coming out like ACID!!!

I am now to meet

on October 11th Wednesday 2023 at 11am:

I was expecting on this day to finally meet **construction** to see her point of view of what could is happening to me after the procedure she had done upon me by lasing the Kidney Stone within me months earlier.

She never turned up.

In the sense like is she dodging me: sick of people saying something came up or they were busy so to me she was dodging me.

assistant met me, and a young woman doctor was present, I told her about my backside and from nowhere assistant asked me if she could stick her finger up my arse anus backside.

What I said to myself.

The assistant to me is racist with a capital RRRRRR!!!

I had E-coli, bacteria from the operation.

The young doctor gave me a prescription for medication.

What am I hearing is exactly true NEGLIGENCE of ones DUTY OF CARE !!!

Getting better, I am about 40-50% and then it happens again I must go back into through Emergency because of my Right Testes are swollen.

The date is November 30th Thursday: 2023

Admitted

From nowhere I had extreme pain within my right testes.

I went to my doctor who said I should go straight up to the hospital and have someone screen my right testes to see what was going on as my testes was swollen and very sore and you could easily see the colour red.

Urology visits me, so this time I am seeing the female Urology Registrar along with male student doctors the male Chinese Doctor who assisted in my first operation/procedure and finally afterwards finding out there is the male DISCHARGE DOCTOR of UROLOGY standing before me.

What!!!

For the first time I am now talking to a FEMALE DOCTOR who is listening to me, one that has common sense and logic, one that is CARING for me.

The FEMALE DOCTOR comes back later to tell that only 2% of patients have an reaction to the Stent that was left with undue care in me for the remainer of when the Stent had to remove to finding out about me having Covid to me waiting around for another 28 days to have it removed just for a five minute procedure to have the Stent removed so this time-frame created bugs within my body downstairs through my penis and my anus, this is why I was told I'm one of only 25 to get this.

I have now stayed a couple of days in hospital, and discharged with medication, and even asked after my ordeal about whether I need a DISCHARGE PLAN!!!

The Discharge Doctor told me if he KNEW I needed a Discharge Plan he would have done it for me and he spoke to me with so much kindness and concern it was not funny.

Amazing about hierarchy here in UROLOGY!!!

The right hand does not know what the left hand is doing!!!

I had an appointment with Urology on **December 1st Friday 2023** at 2pm, to where the appointments cancelled.

Because of the fluid of either water or urine going down through my arse/anus, so Urology has got me an appointment **December 5th Tuesday 2023** at 9am: to see about a Colonoscopy.

So, I have seen him and awaiting the Colonoscopy.

So unexpected I now have an appointment on January 4th Thursday 2024 at 2.45pm Full Bladder with Urology.

I have turned up for this appointment and I have seen a Junior Doctor of Urology, not as he is present in another room somewhere, attending other patients.

I told the young doctor of Urology that my penis is still sore inside where the catheter was, and it seems like inside my penis slight numbing to numbing from within.

I told her my penis is going inwards and that I could not get an erection and is there anything to help with it.

My urine when urinating was still going everywhere like a shower head or sprinkler so I needed to sit down, and it would cause me embarrassment when in the public eye due to fact I could not stand at the trough.

By me telling the young doctor this did not seemed to faze her about what I was telling her she was just taking notes.

So, she left and seen about getting medication so that I could be able to get an erection.

She had a prescription that I had to pharmacy to where I waited and picked the medication up and then I went home.

asked me how things were, and I said it was good I didn't tell her about the medication to get an erection and she replied so they have you still back on medication in which I said yes its only for a little time and then it will be all over.

So, I started to take the medication it had warning signs on it where one could get out it plus one's heart rate may increase.

Do you know I took the medication which was supposed to be stronger than Viagra, and it did not do a thing for me over fourteen nights as I tried this.

My penis is still inwards and remains the same today.

I am now expecting a phone call appointment over the phone on May 17th Friday: 2024.

And still awaiting to find out when I will be having a Colonoscopy.

Conclusion

In **Summary** about my experience with the **second second sec**

who was the first surgeon to operate failed to give me a DISCHARGE PLAN knowing himself that I was in a serious condition to where he knew himself of the ramifications of the KIDNEY STONES.

knew this wasn't a normal operation at all.

He failed to COMPLY with Australian Health rules to where he should have complied with CLOSING the GAP to First Nations Peoples and myself been a First Nation person.

His overall actions tell me he is a RACIST and couldn't be care about the outcomes that I had to go through.

He gave no information about what I was going to go through in this endurance.

The second operation which was done by **second second second** she couldn't have cared less about how I was going to feel like after the ordeal I had to endure from her procedure and gave no information nor did she tell me that my ordeal was going to go through because she knew that my current condition was going to get worse and that she also knew that this procedure was not a normal operation from the first operation. failed to give me a DISCHARGE PLAN.

She failed to COMPLY with Australian Health rules to where she should have complied with CLOSING the GAP to First Nations Peoples and myself been a First Nation person.

Overall, her actions tell me she is a RACIST and couldn't be care about the outcomes that I had to go through.

The third is about the Head/Nurse in Urology who failed to have any type of Kindness to point me in the direction of Whoever just to have the stent removed, due to Covid.

No information nor any type of DISCHARGE PLAN to combat another 28 days that I would have to endure instead she couldn't care less.

She failed to COMPLY with Australian Health rules to where she should have complied with CLOSING the GAP to First Nations Peoples and myself been a First Nation person.

Overall, her actions tell me she is a RACIST and couldn't be care about the outcomes that I had to go through.

The fourth is about the Doctor who was going to remove the stent because he didn't or couldn't be careless about the colour of my penis going blue and that it was turning whitish what does that tell me.

Inexperience to identify the dangers of my penis been the colour that it was and how sick my penis looked like.

He should have referred me onto a Urology who could diagnose me properly for the right advice and how to handle this situation.

He to never gave me a DISCHARGE PLAN.

He failed to COMPLY with Australian Health rules to where he should have complied with CLOSING the GAP to First Nations Peoples and myself been a First Nation person.

Overall, his actions tell me he is a RACIST and couldn't be care about the outcomes that I had to go through.

To find out from someone else especially an Australian woman about a DISCHARGE PLAN tells me so much here about RACISIM.

For to see that day the look on his face when he seen the SCAR TISSUE of his handy work of how he hacked into me was disgusting.

And then finding out what he done to me during the first operation blew my mind out, so he was trying his hardest to cover his tracks.

I am back in **Control of the set of the set**

I have another appointment with the second surgeon, and she hasn't got the guts to front me so what does this tell me with her excuses from her abuse of my body.

Fancy, assistant wanting to stick her finger up my arse/anus blew me out of the room and her smile just gave it all away the RACISM that she had within her disgusting.

And to find out I have had E-coli bacteria in both my penis and anus is breath-taking.

To make things worse my right testes has swollen due to E-coli and this all stems from a NORMAL KIDNEY STONE operation and nearly dying from it.

Neglect of duty I say.

To meeting the female Urology Registrar and the male DISCHARGE DOCTOR of UROLOGY standing before me.

They absolutely apologised for the actions of their colleagues, so they know themselves that the Urology Department isn't doing their jobs properly.

So, some good came out of it but for the rest just pure RACISM.

This has become so serious to where my penis is going inwards and retaining itself in that position to where I cannot get an erection.

So, I am awaiting the Colonoscopy and inside my penis there still is problems and this all is due to negligence of the Urology team, lack of a discharge plan, gaslighting and hospital Covid procedures. There was no Closing the Gap considerations or respect forthcoming to me as an Aboriginal Elder in my 60s which smacks of RACISM!!!
