Dear Yoorook Justice Commission,

I am from Swan Hill in Northern Victoria. However, when my Irish ancestors arrived in Australia, they settled in the region of the Koroit Gunditjmara clan, near Port Fairie and Waarnambul. My Irish ancestor, William Crowe, was one of the founders of the Borough of Koroit, and was Mayor of Koroit when Victoria's first national park was declared in 1892 - the Tower Hill National Park, on the land of the Koroit Gunditjmara.

When I was growing up in Swan Hill, my Uncle Jimmy Crowe bought the land along the banks of the Murray River on the New South Wales side of the river, behind the Federal Hotel. In 1984, Auntie Helen Atkinson, the Chairwomen of the Wamba Wamba Aboriginal Land Council, wrote to my Uncle Jimmy, and asked him to cancel the Crown lease he held on the land direct beside and behind the Federal Hotel so that she could raise a land rights claim on behalf of Wamba Wamba. He did as Auntie Helen asked, and Uncle Jimmy and his family have been neighbours ever since.

Around that same time, 1984, there was a terrible famine in Ethiopia. Thousands of children were dying of starvation. My family and another family had just built that big grain shed you can see a couple of kilometers from Swan Hill on the road into New South Wales, and there had been a bumper harvest, so it was full of grain. My grandfather and I discussed the photos of children starving to death in Ethiopia and asked me "what would you do to help them". I responded "I would find a way to feed them". He smiled at me and shook my hand and that became a pledge I gave my grandfather to dedicate my career to finding a solution to end famine in the world.

I did well academically at Swan Hill High School. I do not remember there being many Aboriginal children at the High School. They mostly went to the Tech School. Towards the end of my high school education I decided that I did not like the bullying I was experiencing and began making friends at the Tech School, including a guy who became my first boyfriend (I'm gay). I went to university and studied Economics and Accounting and began a career as an auditor. However, back in those days (mid 1980s) it was difficult for gay people because homosexuality was illegal or had only just been decriminalised in most Australian States and so our relationship broke up. My life was being manipulated by forces I did not understand until years later. I soon found myself relocated by my employer (PwC) to Perth, WA, where I began making Aboriginal friends who I have stayed in touch with all my life and met my first Aboriginal boyfriend. However, my life was still being manipulated by forces I only later discovered are senior politicians and people who wanted to suppress my what I now know as my family legacy and relationships with indigenous people. I only found out the reasons why, more than twenty years later, beginning in 2017.

In 1997 I left Australia for London, and a big part of the reason was to escape bullying, which had intensified in Perth. I did not understand what was going on. I found myself set up for blackmail and extortion but did not know the reasons why. Shortly after I arrived in London in 1997, at Easter Time, there was an Irish Republican Army bomb scare on my place of employment (Embankment Place, the offices of PwC, on the Thames). Our building was evacuated. I was wandering around outside in the warm Spring sunshine, when suddenly a TV camera was shoved in my face and I found myself being interviewed about the IRA bomb scare. I told the interviewer that I thought the bomb scare was ridiculous. Nobody knew what the IRA are fighting about anymore and that whilst the rest of the world is coming together, the IRA are still trying to tear Ireland apart. Exactly a year later, the Good Friday Peace Accord was signed in Ireland, ending the violence and bloodshed there. It was more than 20 years later that I found out my ancestors in Australia were Irish Fenian (secret society) resistance leaders.

In 2010, there was an economic crisis in the USA. I was living in Ireland at the time and had an idea to help save the US economy. Obama was President. I presented my idea to the US embassy in Dublin. I was told by US National Security staff that it was the best idea they'd ever heard from a banker. My idea was adopted by President Obama and has since become known as his "SupplierPay Pledge" policy. See: [supplierpay_pledge.pdf \(archives.gov\)](#). I then went on to develop a digital bill of exchange (an electronic, post dated cheque), to help fulfill my pledge to my grandfather to dedicate my

career to ending famine in the world. I now believe that I was deliberately "activated" by the Obama Administration - like a Cold War sleeper agent, because of what I discovered when I returned to Australia.

I returned to Australia in 2017. Whilst I was in London, an old banker gave me a hint that perhaps I should investigate my family history. I then discovered our past, including things that happened in Koroit in the lands of the Koroit Gunditjmarra, at the time of the Frontier Wars, that the government has covered up. I believe some of those things have profound significance for Aboriginal people, including through until today. I also discovered when I returned that the government had attacked the dairy farming families whose interests my grandfather and ancestors had represented, including through the trafficking of undocumented horticulture workers to undermine their business models and strip them of their assets so they could be laundered by large corporate agribusinesses and trade union controlled superannuation funds. And I discovered that one of the key motivations of the government is to deny the rights of Aboriginal tribes to water within the Murray Darling Basin System, following the Mabo and Wik decisions in the High Court of Australia in the 1990s. My audit work came to the attention of the old enemies who had set me up for blackmail and extortion in Perth back in the early to mid 1990s. I discovered that police in Swan Hill and Mildura had turned a blind eye to the trafficking of tens of thousands of undocumented Asian horticulture workers into our communities in Northern Victoria. I worked with the Interim CEO of Wamba Wamba Aboriginal Land Council (Uncle Col Williams) to make a submission to the Australian Consumer and Competition Commission inquiry into the Murray Darling Basin water markets. Uncle Col and I worked together as a team. He also gave me his support to make a submission to the UN Human Rights Council. I also interviewed dozens of farmers from Northern Victoria and my work is a key part of the current supermarkets duopoly investigations that are taking place in Australia right now (March 2024).

I was trying to understand what had happened in Australia in the 20 years since I was away. When I left in 1997, Australia appeared to be on a path to Reconciliation and a Treaty. When I arrived back in 2017, I came to the conclusion that things went off the rails during the period when John Howard was Prime Minister. And they've never fully recovered since. I came to the conclusion that the Murdoch family and News Corp together with corporate lobbyists such as Crosby Textor, have been bribing Australian politicians on behalf of their clients in the resources industry ... coal mining and the like. Including clients who are located in the UK and USA. And so I began gathering evidence. On Good Friday (yesterday), 27 years after my BBC interview about the IRA bomb scare, I made a submission to the US Securities and Exchange Commission (US SEC), the regulator of News Corp who own Sky News, under the US Foreign Corrupt Practices Act, alleging that they together with the Murdoch family have been bribing Australian politicians on both the left and right sides of Australian politics, for more than 30 years. Part of my submission includes evidence I've gathered from my ancestors' relationships with indigenous peoples in Australia and across our region, including in Papua New Guinea. It includes evidence that Aboriginal tribes have a hidden, constitutional right to water, and those rights have been stripped from them by the Murdoch family, News Corp and corrupt Australian politicians, together with the constitutional rights to freedom of all Australians, as part of the 2007 Water Act, hidden behind the War in Iraq. I'd like to contribute my submission to the US SEC to the Yoorrook Justice Commission.

This is a message for Northern Ireland's First Minister, Michelle O'Neill, and Deputy First Minister Emma Little-Pengelly. It follows the announcement this week that Jeffrey Donaldson, the pro-UK Democratic Unionist Party has stepped down after being charged with historic sex offenses. I want to share with you my own story. There's probably no better summary than the one below, which I made earlier today to the Yoorrook Justice Commission, an Aboriginal truth telling commission with all the powers of a Royal Commission that is taking place here in Australia. I believe my interview with a BBC journalist following an IRA bomb scare on Good Friday 1997 may have contributed to the Good Friday Peace Accord exactly a year later. And then in 2010, I created the original policy concept for the Obama Administration's SupplierPay Pledge policy, for which credit was then claimed by Lex Greensill and UK PM David Cameron, leading to the Greensill Scandal.

My ancestors' legacy here in Australia is covered up by national secrecy laws and is the subject of a national security veto. I was not aware of it whilst I was growing up. [Redacted]

I'm sharing this with you because (a), eventually I'd like to be able to contribute to the success of Northern Ireland and ideally, eventually, the reunification of the isle of Ireland. But also (b) things were similarly unsettled in Northern Ireland

back in the day. I wonder if Jeffrey Donaldson may have also been set up? It's worth thinking about. I know you have to focus on bread and butter issues to make things a success for everyday people in Northern Ireland. But if there's any doubt in your mind that Donaldson was set up, then please give some thought to that. I'm hoping that justice will prevail here. And if I can help there, including making a contribution to Reconciliation and overcoming barriers to your goals, I'm willing to help. I'm not shy, so I don't mind speaking about my experience publicly, if that would help you and the people of Northern Ireland.

Dear Prime Minister Varadkar,


I draw your attention to my email yesterday to the Northern Ireland First Minister and Assistant First Minister. I'm sharing this with you because I was in Ireland, working for Citibank in 2010, when I was invited to the US Embassy where I met US Assistant Ambassador to Ireland, John Hennessy-Niland and presented the concept for the Obama Administration's SupplierPay Pledge.

I'd like all Irish politicians to know what the British and Australian Governments have been getting up to. All Australian Section 100 constitutional rights to water are our constitutional civil liberties and rights to freedom. That section of our constitution is the legacy of the Irish Australian families who survived the Irish Famine. It is there to protect us against the threat of absentee landlords. 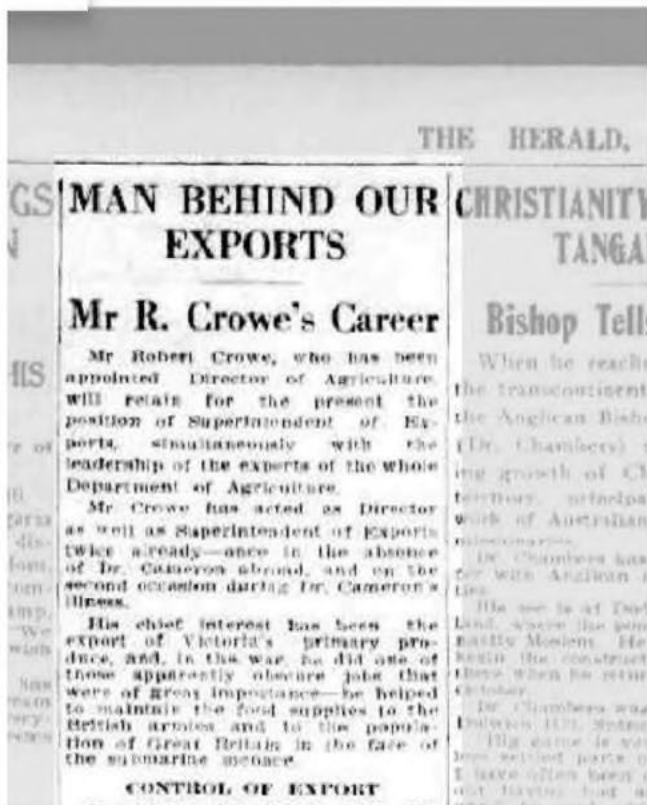

I'm an advocate for Aboriginal rights to water in the Murray Darling Basin. I firmly believe that there is recognition for Aboriginal rights to water in the Australian Constitution, in the "Flora" section (Section 100, "water for conservation purposes"). I don't believe it is a racist clause. It is just that at the time the Australian Constitution was being written, there were some who were trying to introduce the White Australia Policy. And the best they could do to get Aboriginal rights into the Australian Constitution was to hide your rights in the "for Conservation Purposes" section.

My credibility on this is because my ancestors helped write the Australian Constitution. My ancestors also created the Commonwealth of Australia's Fresh Produce Exports department, and opened up our exports of beef to China in 1931. In 1924/5, one of my ancestors led Australia's exhibition at the British Empire Exhibition in London. The reason why it is not widely known is because my ancestors were Irish Fenian leaders (like the Irish mafia), and it is all still hidden behind Australian National Security and Secrecy laws. And in 1892, they created Victoria's first national park (Tower Hill National Park), to commemorate and honour the lives of Aboriginal people who were massacred in the Western Districts of Victoria. That's what this news story from 1892 means - [A Humorous Kind of Mortgage - 22 Jul 1892 - A HUMOROUS KIND OF MORT-GAGE. - Trove \(nla.gov.au\)](#) - i.e. it means a debt owed to Aboriginal people that can never be forgiven.
