In the year of our Lord one thousand eight hundred and fifty one, I Patrick Morgan, of Geelong, in the County of Grant, in the Colony of Victoria, Cordwainer, did for the consideration therein mentioned, convey and assign unto John O'Shanassy, of Melbourne, in the Colony of Victoria, Draper, and Michael Hynes, of Geelong, in the said Colony Licensed Victualler, all my estate and effects whatsoever, Real and Personal for the benefit of all my Creditors; which Indenture was duly executed by me, the said Patrick Morgan and the said Trustees, and duly attested according to the provisions of an Act of the Governor and Council of New South Wales, passed in the fifth year of the Reign of Her Majesty Queen Victoria, intitled "An Act for the further amendment of the Laws, and for the better advancement of Justice," And an Act of the said Governor and Council, passed in the seventh year of the Reign of Her said Majesty, intitled "An Act for giving relief to Insolvent Persons, and providing for the administration of Insolvent estates and to abolish Imprisonment for Debt, and the said Indenture is now lying at the Office of Mr James Elliott, Solicitor, Malop-street, Geelong, for inspection and execution by the Creditors.

**A** NUMBER of residents in the vicinity of the Hopkins, having for years experienced great inconvenience in procuring Rams, have conceived the idea, that the holding of an Annual Fair and Sale would save much trouble to both buyers and sellers, and in consequence an advertisement was inserted in the *Intelligencer* newspaper, calling a meeting on the 20th instant, at Mr Farrell's Inn, on the Hopkins, of those interested in the improvement of sheep and Wool, for the purpose of forming a Society. In pursuance of the above advertisement a number of the neighbouring stockholders having met, the following resolutions were proposed and carried,

- 1st.—That Mr James Chrisp do take the Chair.
- 2nd.—That a Society be formed for the improvement of sheep and wool, to be entitled "The Hopkins River Ram Fair and Sale," and that the annual subscription to which, shall be £2 2s.
- 3rd.—That the "Annual Fair and Sale" be held on the first Wednesday of September.
- 4th.—That in the event of the majority of the members deeming it advisable, prizes will be offered for various descriptions of Stock, on the Second Annual Meeting of the Society.
- 5th.—Any Sweepstakes entered into by members, on notice being given to the Secretary, shall be provided for

here, on notice being given to the Secretary, shall be provided for the Stock, and Judges will be appointed by the Committee to decide the same on the Fair Day

- 6th.—That the co-operation of the Stockholders of the Province be invited by either sending Rams or other Stock to this Fair, for sale by auction or otherwise, and that the Committee guarantee the attendance of an auctioneer, who shall be the only public salesman on that day.
  - 7th.—That notice be sent to the Secretary fourteen days before the Fair, of the number, and description of Stock intended to be sent for sale, to enable the Committee to procure accommodations.
  - 8th.—That all exhibitors of Stock must be members.
  - 9th.—That any gentleman desirous of joining this Society, will please forward notice of the same to the Secretary.
  - 10th.—That the following gentlemen be appointed a Committee, with power to add to their number, five to constitute a quorum:—

  - 12th.—That the Secretary be instructed to advertise the proceedings of this meeting in the 'Daily News,' 'Intelligencer,' and 'Portland Guardian,' news papers.
  - Lastly.—The thanks of the meeting were voted to Mr Chrisp for his conduct in the chair, and for the trouble he had taken in organizing the Society.
